1. Entry deadline is Friday, February 20, at 12:00 noon. Late entries can be accommodated with prior arrangement.

3. Wristband will be issued to child listed on entry form. Your wristband must be on your wrist. These wristbands are for gate entry for the cook-off only.
4. **Each team is responsible for their own trash. Boxes, foil pans, etc. shall be taken to the dumpster by the team provided by MCFLA.**
5. Each team will receive their turn in containers and QR codes from the CBA representative.
